Today, we offer comprehensive assistance and strategic solutions for the design, implementation and support of all material handling needs to our diversified customer base in North Carolina, South Carolina, Georgia, Alabama and the central time zone of Florida. We have over 500 Associates, including over 250 Service Technicians in facilities strategically located throughout the market.

Describe the defining moment when you knew Carolina Handling would be successful.

In 1989, Don Pratt retired and Tim Hilton, then the President of the company, became the principal shareholder. The Raymond Corporation joined Carolina Handling as an equity partner in January 1995. This decision reflected both companies' philosophy to build a true partnership and an even stronger company. In 2014 Dave Reder was announced as our new President and CEO. Under the leadership of his management team we have experienced record growth as a company.
